**AN ORDINANCE REPEALING THE MONCADA MUNICIPAL FISHERIES  
ORDINANCE OF 2002 WHICH SHALL BE KNOWN HEREAFTER AS  
MONCADA FISHERIES ORDINANCE OF 2025**

**BE IT ENACTED** by the Sangguniang Bayan of Moncada, Tarlac in session assembled, that:

**Section 1.** This ordinance shall be known as the "**REVISED MONCADA MUNICIPAL FISHERIES ORDINANCE OF 2025.**"

**Section 2.** The Municipal Government Fisheries herein referred to include Banaoang-Calandong River, Soco-Lanat Creek, and Bulog Creek.

**Section 3.** Bidding shall be scheduled on May 15, 2025, and every three years thereafter. However, notice of public bidding shall be published on the Bulletin Board at the Municipal Building and three (3) conspicuous places two (2) weeks before the scheduled bidding.

**Section 4.** Bidding shall be open to all residents of Moncada who are citizens of the Republic of the Philippines and who have resided in this municipality for at least one (1) year before the date of the bidding.

**Section 5.** The ceiling price of any of the above-mentioned fisheries shall be decided by the Municipal Fisheries Bidding Committee, composed of the COA

Representative, Municipal Treasurer, Municipal Budget Officer, Committee on Finance, Ways and Means and Appropriations, and Committee on Agriculture.

The lease amount shall be increased by ten percent (10%) annually for Soco-Lanat Creek and Bulog Creek under a negotiated contract.

**Section 6.** In case of three (3) consecutive failed biddings, the Municipal Government shall have the option to manage the subject fisheries or award the same to qualified parties by means of a negotiated contract to be paid in quarterly basis under a three-year term.

**Section 7.** A bid proposal must be accompanied by a bidder's bond of one thousand pesos (P 1,000.00) which shall be paid to the Municipal Treasurer.

**Section 8.** The successful bidder shall execute a contract within five (5) days from the date of the award; otherwise, the cash bond shall be forfeited in favor of the Municipal Government.

**Section 9.** Failure of the winning bidder to execute a contract within five (5) days from the date of the award shall cause his/her disqualification from managing and operating the bidden municipal fishery.

**Section 10.** The successful bidder shall pay forty percent (40%) of the total bid amount outright upon winning the bid. Thirty percent (30%) shall be paid on the second year of the contract, and the remaining thirty percent (30%) shall be settled on the third year to qualify for the next bidding process.

**Section 11.** The term of the contract of the successful bidder shall be three (3) years, starting on May 15 of the first year and expiring on May 15 of the third year.

**Section 12.** Any existing ordinances that are inconsistent with any provisions of this ordinance are deemed repealed.

**Section 13.** This ordinance shall take effect fifteen (15) days following its posting in at least three (3) conspicuous places in the Municipality and/or on social media platforms of the LGU.
