**WHEREAS**, Section 48 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that local legislative power shall be exercised by the Sangguniang Bayan for the municipality;

**WHEREAS**, Section 50(a) of the same law mandates the Sangguniang Bayan to adopt or update its Internal Rules of Procedure within ninety (90) days from the first regular session following the election of its members;

**WHEREAS**, Section 50(b)(1) further provides that the rules of procedure shall include the organization of the Sanggunian, including the election of its officers, the creation of standing committees, the determination of the general jurisdiction of each committee, and the election of the chairperson and members thereof;

**WHEREAS**, during the inaugural regular session held on July 8, 2025, the Sangguniang Bayan, upon motion by the Floor Leader and with no objections, proceeded with the designation of committee chairpersons, vice chairpersons, members, and district representatives, pursuant to the adopted Internal Rules of Procedure;
