RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH HONORABLE MAYOR RAMON BENITO M. AQUINO, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CENTRAL LUZON DOCTORS' HOSPITAL FOR THE STRENGTHENING OF THE LOCAL HEALTH REFERRAL SYSTEM AND THE PROVISION OF MEDICAL AND HEALTH-RELATED SERVICES

WHEREAS, the Municipal Government of Moncada recognizes the need to strengthen its health referral system to ensure timely, coordinated, and quality health services for its constituents, particularly during medical emergencies and specialized care situations;

WHEREAS, the Central Luzon Doctors' Hospital (CLDH), a reputable private hospital in the region, has expressed willingness to enter into a formal partnership with the Municipal Government of Moncada to support and enhance the delivery of health-related services;

WHEREAS, the proposed Memorandum of Agreement aims to establish a referral and service coordination framework between the Municipality of Moncada and CLDH, covering areas such as patient referral protocols, medical support services, health information exchange, and possible extension of outreach or community-based programs;

WHEREAS, the partnership is expected to contribute significantly to the improvement of local health outcomes and aligns with the objectives of Republic Act No. 11223, otherwise known as the "Universal Health Care Act," which

promotes health system integration and the provision of accessible, quality healthcare services;

WHEREAS, Section 22(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the local chief executive to enter into contracts and such other transactions on behalf of the local government unit, subject to the authorization of the Sangguniang Bayan;

NOW, THEREFORE, on motion by Coun. Janius John C. Yasay, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, hereby authorizes the Municipal Government of Moncada, through Honorable Mayor Ramon Benito M. Aquino, to enter into a Memorandum of Agreement with the Central Luzon Doctors' Hospital (CLDH) for the strengthening of the local health referral system and the provision of medical and health-related services for the benefit of Moncada residents;

RESOLVED, FURTHER, that copies of this resolution be forwarded to the Office of the Municipal Mayor, the Municipal Health Office, and the Central Luzon Doctors' Hospital for their information and appropriate action.
