**RESOLUTION APPROVING THE REVERSION OF A PORTION OF THE FY 2025 20% DEVELOPMENT FUND OF THE MUNICIPALITY OF MONCADA FOR THE IMPLEMENTATION OF OTHER PRIORITY PROJECTS IN THE BARANGAYS**

**WHEREAS**, the amount of ₱11,850,000.00 was originally allocated under the FY 2025 20% Development Fund for the construction of a six-room, two-storey multipurpose building intended as the college building of the Moncada Polytechnic College;

**WHEREAS**, the Local Government Unit (LGU) of Moncada has determined that there is already an existing two-storey building in Barangay Rizal with available classrooms that can serve as the temporary facility for the Moncada Polytechnic College;

**WHEREAS**, in consideration of this available infrastructure, the LGU finds it more prudent to pool resources and focus investments on the said existing building in the meantime, deferring the construction of the proposed multipurpose building;

**WHEREAS**, the reversion of the ₱11,850,000.00 allocation will allow the municipality to utilize said funds within FY 2025 for the implementation of other priority projects in the barangays, thereby maximizing the use of public funds and addressing immediate community needs;
