RESOLUTION AUTHORIZING THE MUNICIPAL GOVERNMENT OF MONCADA, THROUGH THE HONORABLE MAYOR ESTELITA M. AQUINO, TO PURCHASE A MULTI-PURPOSE MOBILE AGRI-SERVICE FOR THE USE OF MUNICIPAL AGRICULTURE OFFICE, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS

WHEREAS, endorsed to the Sangguniang Bayan is a project proposal from the Municipal Agriculture Office in connection with the proposed procurement of a Multi-Purpose Mobile Agri-Service that aims to mobilize agriculture extension services to the barangays of Moncada;

WHEREAS, the core objectives of the aforesaid project include facilitating for timely delivery, of quality basic agricultural services to clientele and to render regular monitoring, documentation and evaluation of agricultural development programs within the municipality;

WHEREAS, the Municipal Agriculture Office of Moncada bagged the Quality Corn Achiever's Award in November 2018, in recognition of its pivotal role in promoting high quality corn production in Moncada;

WHEREAS, the said award comes with a cash prize of One Million Pesos (P1,000,000.00), which shall be earmarked for purposes of agriculture program development and other relevant programs deemed vital in the furtherance of its goals and objectives;

WHEREAS, the funding for the proposed agriculture service vehicle shall be derived from the cash prize received by the LGU of Moncada, through the Municipal Agriculture Office;

NOW, THEREFORE, premises considered and on motion by Coun. Ruben V. Gamboa, Jr, duly seconded;

RESOLVED, that the Sangguniang Bayan of Moncada, acting on the favorable recommendation of the Committee on Agriculture and Natural Resources, hereby AUTHORIZES the Municipal Government of Moncada, through the Honorable Mayor Estelita M. Aquino, to purchase a Multi-Purpose Mobile Agri-Service for the use of Municipal Agriculture Office, subject to the existing laws, rules and regulations;

RESOLVED FURTHER, that the LGU of Moncada shall shoulder other expenses as augmentation for the purchase, operation and maintenance of the said service vehicle;

RESOLVED FINALLY, that copies of this Resolution be furnished the Honorable Mayor Estelita M. Aquino, the Municipal Agriculture Office, and all concerned agencies/offices for their information and appropriate action.
