### RESOLUTION AUTHORIZING SUPPLEMENTAL BUDGET NUMBER 1 FOR THE IMPLEMENTATION OF THE FOURTH TRANCHE COMPENSATION ADJUSTMENT IN THE LOCAL GOVERNMENT UNIT EFFECTIVE JANUARY 1, 2019, PURSUANT TO DEPARTMENT OF BUDGET AND MANAGEMENT LOCAL BUDGET CIRCULAR NUMBER 118, SERIES OF 2019

WHEREAS, one of the vested powers of the Sanggunian, as a legislative body, is to approve resolutions appropriating funds for the general welfare of the municipality and its inhabitants and shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services and activities of the municipal government;

WHEREAS, Local Budget Circular Number 118 Series of 2019 dated January 15, 2019 is issued by the Department of Budget and Management to prescribe guidelines, rules and regulations for the implementation of the fourth tranche compensation adjustment in local government units;

WHEREAS, implementation of these compensation adjustments provided in the LBC 118, series of 2019 shall be effective not earlier than January 1, 2019;


