**CONFIRMING THE APPOINTMENT OF CRISTINA A. GABRIEL AS FULL-FLEDGED MUNICIPAL TREASURER OF MONCADA LOCAL GOVERNMENT UNIT**

WHEREAS, Section 443 (d) of Republic Act 7160 or the Local Government Code provides that heads of offices and departments in the LGUs shall be appointed by the municipal mayor, unless otherwise provided herein, with the concurrence of a majority of all members of the Sanggunian, subject to civil service law, rules and regulation. The Sangguniang Bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

WHEREAS, Article Two, Section 470 of the foregoing Act provides the Qualification, Appointment, Qualifications, Powers, and Duties of the Treasurer, to wit:

- (a) The treasurer shall be appointed by the Secretary of Finance from a list of at least three (3) ranking, eligible recommendees of the governor or mayor, as the case may be, subject to civil service law, rules and regulations.
- (b) The treasurer shall be under the administrative supervision of the governor or mayor, as the case may be, to whom he shall report regularly on the tax collection efforts in the local government unit;

- (c) No person shall be appointed treasurer unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, a holder of a college degree preferably in commerce, public administration or law from a recognized college or university, and a first grade civil service eligible or its equivalent. He must have acquired experience in treasury or accounting service for at least five (5) years in the case of the city or provincial treasurer, and three (3) years in the case of the municipal treasurer.

WHEREAS, the Department of Finance, through Secretary Carlos G. Dominguez, issued the appointment of Cristina A. Gabriel on December 27, 2018 pursuant to Civil Service law, rules and regulations on appointment of career officials;

WHEREAS, the appointment of Cristina A. Gabriel, Municipal Treasurer, is in order having met the minimum requirements provided by law;

NOW, THEREFORE, premises considered, and on motion by Coun. Janius M. Yasay, duly seconded;


RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules, Ordinances and Justice, hereby CONFIRMS the appointment of CRISTINA A. GABRIEL, as full-fledged Municipal Treasurer of Moncada Local Government Unit;

RESOLVED FURTHER, that the appointee shall enter upon the performance of duties of the Municipal Treasurer, furnishing the Civil Service Commission of copies of her appointment along with this concurrence;

RESOLVED FINALLY, that copies of this Resolution be furnished the Municipal Mayor, Municipal Human Resource Management Office and all concerned offices and agencies for their information and appropriate action;
