RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Cleofé D. Favis, District I Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay Poblacion # 4, this municipality, in the
