RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY MALUAC, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION THREE HUNDRED TWENTY SIX THOUSAND FIVE HUNDRED SEVENTEEN PESOS AND 66/100 (Php 2,326,517.66) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
