**RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY TOLEGA NORTE, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FORTY ONE THOUSAND TWO HUNDRED THIRTY SEVEN PESOS AND 05/100 (Php 1,841,237.05) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY**
