RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY TOLEGA NORTE, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FORTY ONE THOUSAND TWO HUNDRED THIRTY SEVEN PESOS AND 05/100 (Php 1,841,237.05) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Section 333 of RA 7160, Barangay Tolega Norte submitted their Annual Budget for CY 2019 to the Sangguniang Bayan, the legislative body vested with the power to review such Barangay Appropriation Ordinance;

NOW, THEREFORE, premises considered, and upon motion by Coun. Janius M. Yasay, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules and Ordinances, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay Tolega Norte, this municipality, in the amount of One Million Eight Hundred Forty One Thousand Two Hundred Thirty
