RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY VILLA, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND EIGHT HUNDRED NINETY ONE PESOS AND 04/100 (Php 1,700,891.04) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
