RESOLUTION APPROVING THE TWENTY PERCENT (20%) DEVELOPMENT FUND APPROPRIATED FOR VARIOUS DEVELOPMENT PROGRAMS, PROJECTS AND ACTIVITIES OF THE MUNICIPALITY FOR CALENDAR YEAR 2020 AMOUNTING TO THIRTY ONE MILLION NINE HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED THIRTY EIGHT PESOS AND 40/100 (PHP 31,949,838.40)
