**RESOLUTION APPROVING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) OF THE MUNICIPALITY OF MONCADA FOR CALENDAR YEAR 2020 AMOUNTING TO EIGHT MILLION SEVEN HUNDRED NINE THOUSAND NINE HUNDRED SEVENTY ONE PESOS (PHP 8,709,971.00)**

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) comprised of local officials, functionaries, sectoral representatives and other stakeholders formulated various programs projects and activities (PPAs) in accordance with the Prevention/Mitigation, Preparedness, Response and Relief/Rehabilitation pillars of Disaster Risk Reduction and Management;

WHEREAS, the MDRRMC consolidated the foregoing programs, projects and activities into a Local Disaster Risk Reduction Management Fund Investment Plan that is consistent with the identified hazards and vulnerabilities in the Municipality;
