RESOLUTION APPROVING THE REALIGNMENT OF THE TWENTY PERCENT (20%) DEVELOPMENT FUND OF THE MUNICIPALITY OF MONCADA FOR CALENDAR YEAR 2019 AMOUNTING TO TWENTY EIGHT MILLION FIVE HUNDRED FIFTY NINE THOUSAND EIGHT HUNDRED SEVENTY TWO PESOS AND 80/100 (PHP 28,559,872.80)

WHEREAS, for consideration of this Sanggunian is the proposed realignment of programs, projects and activities (PPAs) contained in the 20% Development Fund of the municipality for CY 2019;
