RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY CAMPOSANTO #2, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED FIFTY FOUR THOUSAND FIVE HUNDRED THIRTY SIX PESOS AND 41/100 (Php 2,854,536.41) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
