RESOLUTION RATIFYING EXECUTIVE ORDER NUMBERED 29, SERIES OF 2019 REORGANIZING THE LOCAL DEVELOPMENT COUNCIL IN THE MUNICIPALITY OF MONCADA

WHEREAS, Article 182 of the Rules and Regulations implementing the Local Government Code states that there shall be a reorganization of Local Development Council (LDC) in every LGU;

WHEREAS, Section 106 of the same Code provides that every LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by the Sanggunian;

WHEREAS, the reorganization of the LDC is in order after having complied the requirements for its composition as provided for under the Local Government Code;
