**RESOLUTION RATIFYING EXECUTIVE ORDER NUMBERED 32, SERIES OF 2019  
REORGANIZING THE LOCAL SCHOOL BOARD IN THE MUNICIPALITY OF  
MONCADA, TARLAC**

WHEREAS, Section 98 of Republic Act 7160 or the Local Government Code states that there shall be an established Local School Board in every Municipality;

WHEREAS, the municipal school board shall be composed of the municipal mayor and the district supervisor of schools as co-chairpersons; the chairperson of the education committee of the Sangguniang Bayan, the Municipal Treasurer, the president of Municipal Federation of Sangguniang Kabataan, the duly elected president of the municipal federation of parents-teachers associations, the duly elected representative of the teachers' organizations in the municipality, and the duly elected representative of the non-academic personnel of public schools in the municipality, as members;

WHEREAS, the said special Body shall serve as an advisory committee to the Sanggunian on matters relevant to education and the uses of local appropriations on education purposes;

WHEREAS, this August Body, upon perusal thereof, finds the same to be in compliance with the Local Government Code;


