**RESOLUTION RATIFYING EXECUTIVE ORDER NUMBERED 35, SERIES OF 2019 REORGANIZING THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) IN THE MUNICIPALITY OF MONCADA, TARLAC**

WHEREAS, Section 43 of Republic Act 6975 otherwise known as the "Department of the Interior and Local Government Act of 1990" provides that Local Government Units shall have a functional and duly established People's Law Enforcement Board (PLEB);

WHEREAS, the PLEB shall be vested with the power and authority to hear and decide on administrative cases which result from improprieties committed by personnel of the Philippine National Police;

WHEREAS, the Municipal Peace and Order Council has passed a Resolution reorganizing the membership of the PLEB;

WHEREAS, this August Body finds the reorganization of PLEB in order considering the proven impartiality, probity, and integrity of the members;
