RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY SAN JULIAN, THIS MUNICIPALITY, IN THE AMOUNT OF THREE MILLION FIFTY SEVEN THOUSAND NINE HUNDRED FIFTY THREE PESOS AND 48/100 (Php 3,057,953.48) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY


