RESOLUTION EARNESTLY REQUESTING THE TARLAC I ELECTRIC COOPERATIVE (TARELCO-I) AND DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO RELOCATE THE ELECTRIC POLES OFF THE ROAD SHOULDERS TRAVERSING THE ENTIRE STRETCH OF MCARTHUR HIGHWAY IN MONCADA

WHEREAS, the Department of Public Works and Highways (DPWH) had undertaken road widening project along McArthur Highway (Manila North Road) traversing the Municipality of Moncada;

WHEREAS, electric poles owned by TARELCO-I that remain along the road shoulders are considered public nuisance and obstruction to free-flow of traffic and thus pose major hazards to motorists using the said highway;

WHEREAS, this August Body had made several attempts requesting the stakeholders and concerned owners of electric poles/posts to relocate the same off the road shoulders to prevent the occurrence of road mishaps, to no avail;

WHEREAS, in support of the government's unremitting efforts to clear major roads and streets, the Sangguniang Bayan of Moncada deems it necessary and urgent to cause the relocation and removal of electric poles that remain along the road shoulders of the National Highway to ensure the safety of motorists and commuters alike;

NOW, THEREFORE, on motion by Coun. Rodolfo C. Espejo, Jr., duly seconded;


