RESOLUTION GRANTING NINE THOUSAND PESOS (Php 9,000.00) LONGEVITY BONUS TO LIVING ELDERLY RESIDENTS OF MONCADA AGED NINETY (90) YEARS

WHEREAS, in the context of this Resolution, the elderlies are presumed to have outlived their productive years and are now mostly confined in the comfort of home under the care of their immediate family;

WHEREAS, the fact about their having contributed something to society during their prime no matter how seemingly insignificant, cannot be ignored, nor the recognition be denied them;

WHEREAS, as a token of gratitude for the good they may have made of what we are today, it is but appropriate that such shall be effected with a nine thousand pesos (P9,000.00) longevity bonus to be awarded in October during "Elderly Week";

NOW, THEREFORE, on motion by Coun. Alberto C. Marzan, Jr., MD, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Social Welfare, hereby grants nine thousand pesos (Php 9,000.00) longevity bonus to living elderly residents of Moncada aged ninety (90) years;

RESOLVED FURTHER, that the following guidelines and requirements shall be complied with in connection with the foregoing grant, to wit:

- 1) That the nine thousand pesos (P9,000.00) longevity bonus shall be granted to elderly residents of Moncada aged ninety (90) years as of September 30, 2019;
- 2) That no elderly shall be granted longevity bonus unless he/she presents proof of his/her age, residency and he/she is a qualified member of the Senior Citizens in Moncada, duly certified by the head of Office of the Senior Citizens Affairs (OSCA) Moncada;
- 3) That the grant of longevity bonus shall be subject to the availability of local funds and shall likewise be subject to the usual accounting and auditing policies, rules and regulations;
- 4) That the Local Chief Executive, through the Municipal Social Welfare and Development Office (MSWDO), shall be authorized to grant longevity bonus to all qualified elderly during the "elderly week" on October of the current year;

RESOLVED FINALLY, that copies of this Resolution be furnished the Honorable Estelita M. Aquino, Municipal Mayor, and all concerned offices and agencies for their appropriate action;
