RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT LOCAL DISASTER RISK REDUCTION MANAGEMENT (LDRRM) MULTIPURPOSE VEHICLE, SPECIFICALLY KNOWN AS TRUCK-MOUNTED CRANE, AMOUNTING TO FOUR MILLION PESOS (Php 4,000,000.00), TO BE CHARGED AGAINST THE 2019 LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF) AND TRUST FUND

WHEREAS, endorsed to the Sangguniang Bayan is a duly approved supplemental Local Disaster Risk Reduction Management Fund Investment Program (LDRRMFIP) containing therein the proposed procurement of one (1) unit LDRRM Multipurpose Vehicle, specifically known as Truck-Mounted Crane amounting to Four Million Pesos (Php 4,000,000.00);

WHEREAS, the primary objective of the project is to ensure the LGU's efficiency in disaster management, rescue and retrieval operations that require the use of heavy equipment as such;
