NOW, THEREFORE, premises considered, and upon motion by Coun. Janius M. Yasay, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules and Ordinances hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay MABINI, this municipality, in the amount
