RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY BANAOANG WEST, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION TWO HUNDRED EIGHTY NINE THOUSAND FOUR HUNDRED SEVENTEEN PESOS AND 69/100 (Php 2,289,417.69) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
