RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY ARINGIN, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION FOUR HUNDRED SIXTY TWO THOUSAND NINE HUNDRED THIRTY ONE PESOS AND 37/100 (Php 2,462,931.37) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
