RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY SAN PEDRO, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED FORTY SIX THOUSAND ONE HUNDRED SEVENTY SEVEN PESOS AND 47/100 (Php 1,746,177.47) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

NOW, THEREFORE, premises considered, and upon motion by Hon. Ruben V. Gamboa Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Ruben V. Gamboa Jr., District VII Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay SAN PEDRO, this municipality, in the amount of One Million Seven Hundred Forty Six Thousand One Hundred Seventy
