RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY SAN JUAN, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION FIVE HUNDRED EIGHTY THREE THOUSAND NINE HUNDRED SIXTY FIVE PESOS AND 76/100 (Php 2,583,965.76) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

NOW, THEREFORE, premises considered, and upon motion by Hon. Ruben V. Gamboa Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Ruben V. Gamboa Jr., District VII Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay SAN JUAN, this municipality, in the amount of Two Million Five Hundred Eighty Three Thousand Nine Hundred Sixty
