RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY STA MONICA, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION FIVE HUNDRED NINETY FOUR THOUSAND FIFTY THREE PESOS AND 92/100 (Php 2,594,053.92) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Thelmaflor A. Espejo, District VI Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay Sta Monica, this municipality, in the
