RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY CAPAOAYAN, THIS MUNICIPALITY, IN THE AMOUNT OF THREE MILLION ONE HUNDRED ELEVEN THOUSAND FIVE HUNDRED FORTY SIX PESOS AND 72/100 (Php 3,111,546.72) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Section 333 of RA 7160, Barangay CAPAOAYAN submitted their Annual Budget for CY 2019 to the Sangguniang Bayan, the legislative body vested with the power to review such Barangay Appropriation Ordinance;

NOW, THEREFORE, premises considered, and upon motion by Hon. Rodolfo A. Espejo, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Rodolfo A. Espejo, District IV Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay CAPAOAYAN, this municipality, in the amount of Three Million One Hundred Eleven Thousand Five Hundred Forty Six
