**RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY CAMPOSANTO 1 SUR, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FOUR THOUSAND SEVEN HUNDRED FIFTY TWO PESOS AND 23/100 (Php 2,404,752.23) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY**

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Janius M. Yasay, District II Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay CAMPOSANTO 1 SUR, this
