RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Janius M. Yasay, District II Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay TUBECTUBANG, this municipality, in the amount of Two Million Seven Hundred Sixty Three Thousand One Hundred Ten


