RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY POBLACION # 2, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FIFTY SIX THOUSAND SIX HUNDRED THIRTY PESOS AND 85/100 (Php 2,456,630.85) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Section 333 of RA 7160, Barangay POBLACION # 2 submitted their Annual Budget for CY 2019 to the Sangguniang Bayan, the legislative body vested with the power to review such Barangay Appropriation Ordinance;

WHEREAS, the foregoing Annual Budget must be given due course and effect on the date of effectivity as specified in RA 7160 which states, "the Ordinance enacting annual budget shall take effect at the beginning of the ensuing calendar year.";

NOW, THEREFORE, premises considered, and upon motion by Hon. Cleofe D. Favis, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Cleofe D. Favis, District I Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay POBLACION # 2, this municipality, in the
