RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2, SERIES OF 2019 RECLASSIFYING PARCELS OF LAND SITUATED AT BARANGAY BURGOS, THIS MUNICIPALITY, OWNED BY ATTY. MA. ALYSSA JELINE A. LAMORENA - ASIATEN FROM AGRICULTURAL TO RESIDENTIAL USE

WHEREAS, Section 447(a) (2) (vii) of Republic Act 7160 otherwise known as the Local Government Code of 1991 authorizes the Sangguniang Bayan to reclassify lands within its territorial jurisdictions;

WHEREAS, section 20 of the same code provides that the Sangguniang Bayan through an ordinance may authorize the reclassification of lands and provide for the manner of its utilization or disposition where the land shall have substantially greater economic value for residential, commercial, or industrial purposes;

WHEREAS, the land to be reclassified is owned by Atty. Ma. Alyssa Jeline A. Lamorena -Asiaten covered under TCT Nos. 043-2017005989, 043-2017005990 and 043-2017006945;

WHEREAS, the necessary documents were submitted by the applicant which satisfy the requirements as provided under Article 38 of the Rules and Regulations Implementing the Local Government Code of 1991 (RA 7160);

NOW THEREFORE, on motion of Councilor Janius M. Yasay and unanimously seconded,

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules and Ordinances hereby APPROVES the reclassification of parcels of land from agricultural to residential use, covered under TCT Nos. 043-2017005989, 043-2017005990 and 043-2017006945 with an aggregate land area of Forty Six Thousand Five Hundred Sixty One (46,561) square meters situated at Brgy. Burgos, Moncada, Tarlac;

RESOLVED FURTHER, that this Resolution be enacted into an Ordinance, to wit:

MUNICIPAL ORDINANCE NO. 02 Series of 2019

AN ORDINANCE RECLASSIFYING PARCELS OF LAND LOCATED AT BARANGAY BURGOS, THIS MUNICIPALITY, UNDER TRANSFER CERTIFICATE OF TITLE NOS. 043-2017005989, 043-2017005990 and 043-2017006945 FROM AGRICULTURAL TO RESIDENTIAL USE

BE IT ORDAINED by the Sangguniang Bayan of Moncada, Tarlac in session assembled, that:

SECTION 1. That the parcels of land situated at Barangay Burgos, Moncada, Tarlac containing an area of Forty Six Thousand Five Hundred Sixty One (46,561) square meters covered under TCT Nos. 043-2017005989, 043-2017005990 and 043-2017006945 are hereby reclassified from AGRICULTURAL to RESIDENTIAL use.

SECTION 2. That the applicant/owner shall be responsible for the relocation and just compensation of the tenants, should there be any on subject properties as provided for under pertinent laws and other rules and regulations.

SECTION 3. That the reclassification of the above-described property from agricultural to residential use shall strictly comply with the existing rules and regulations under RA 7160, particularly the required permits and all other forms of taxes, fees and charges that the Municipality of Moncada shall impose.

SECTION 4. Any law, ordinance, or issuance inconsistent with any provision hereof is hereby repealed or modified accordingly, provided it is not contrary to the Comprehensive Land Use Plan of the Municipality of Moncada.

SECTION 5. This Ordinance shall take effect upon its approval.
