RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY ATENCIO, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION SIX HUNDRED SEVENTY TWO THOUSAND SEVEN HUNDRED NINETY FOUR AND 80/100 (Php 1,672,794.80) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Ruben V. Gamboa, Jr., District VII Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay ATENCIO, this municipality, in the
