RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY CAMANGAAN EAST, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION THREE HUNDRED FORTY EIGHT THOUSAND EIGHT HUNDRED TWENTY ONE AND 93/100 (Php 2,348,821.93) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Rodolfo A. Espejo, District IV Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay CAMANGAAN EAST, this
