RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY RIZAL, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION TWO HUNDRED TWENTY SEVEN THOUSAND FOUR HUNDRED THIRTY SEVEN AND 48/100 (Php 2,227,437.48) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Section 333 of RA 7160, Barangay RIZAL submitted their Annual Budget for CY 2019 to the Sangguniang Bayan, the legislative body vested with the power to review such Barangay Appropriation Ordinance;

WHEREAS, Annual Budget for CY 2019 of Barangay RIZAL was thoroughly reviewed by the Sangguniang Bayan with the technical assistance from the Municipal Budget Officer and the same had been found to be in order;

WHEREAS, the foregoing Annual Budget must be given due course and effect on the date of effectivity as specified in RA 7160 which states, "the Ordinance enacting annual budget shall take effect at the beginning of the ensuing calendar year.";

NOW, THEREFORE, premises considered, and upon motion by Hon. JANIUS M. YASAY, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Janius M. Yasay, District II Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay RIZAL, this municipality, in the

amount of Two Million Two Hundred Twenty Seven Thousand Four Hundred Thirty Seven And 48/100 (Php 2,227,437.48) and declaring the same to be OPERATIVE in its entirety;
