RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Cleofe D. Favis, District 1 Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay POBLACION #1, this municipality, in the
