RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY POBLACION #3, THIS MUNICIPALITY, IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED NINETY THOUSAND FIVE HUNDRED SEVEN PESOS AND 13/100 (Php 1,890,507.13) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
