RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY BURGOS, THIS MUNICIPALITY, IN THE AMOUNT OF TWO MILLION EIGHT HUNDRED SEVENTY SIX THOUSAND SIX HUNDRED FORTY THREE PESOS AND 65/100 (Php 2,876,643.65) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
