RESOLVED, that this Sanggunian, acting on the favorable recommendation of Hon. Edward V. Tolentino, District 8 Councilor, hereby APPROVES upon review the Annual Budget for Calendar Year 2019 of Barangay BURGOS, this municipality, in the amount of Two Million Eight Hundred Seventy Six Thousand Six Hundred Forty Three
