RESOLUTION APPROVING UPON REVIEW THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF BARANGAY ABLANG-SAPANG, THIS MUNICIPALITY, IN THE AMOUNT OF THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND EIGHT HUNDRED TWENTY ONE PESOS AND 56/100 (Php 3,880,821.56) AND DECLARING THE SAME TO BE OPERATIVE IN ITS ENTIRETY
