**RESOLUTION ADOPTING THE ANTI-CRIMINALITY ACTION PLAN - "IMPLAN PAKSYATEN TI MAIPARIT A DROGA", BEING PROPOSED BY THE MONCADA POLICE STATION FOR IMPLEMENTATION IN THE MUNICIPALITY OF MONCADA, TARLAC FOR 2019**
