**RESOLUTION SUPPORTING THE IMPLEMENTATION OF THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS (SPISC) PROGRAM OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT IN THE MUNICIPALITY OF MONCADA**

WHEREAS, the Philippine Government has made great strides in promoting the welfare of its people, particularly senior citizens, by legislating national policies in response to their emerging needs;

WHEREAS, Republic Act No. 9994 or the "Expanded Senior Citizens Act of 2010" institutionalizes social protection to senior citizens by providing additional government assistance through Social Pension for Indigent Senior Citizens (SPISC), which entitles them to a monthly stipend of Five Hundred Pesos (Php 500.00) to augment their daily subsistence and other medical needs;

WHEREAS, the Department of Social Welfare and Development (DSWD), as the lead agency in social welfare and development, implements the SPISC in the country through the DSWD Field Offices (FOs) using the most cost-effective and efficient mode of payment to deliver the stipend to the beneficiaries every quarter;

WHEREAS, in the implementation of the program, the DSWD has issued various guidelines, memoranda and administrative orders to respond to the issues and concerns encountered providing a unified direction for DSWD FOs, in partnership with the Local Government Units (LGUs) to ensure an effective and efficient implementation of the program.



## **SANGGUNIANG BAYAN**

WHEREAS, the Local Government Unit of Moncada, through the Municipal Social Welfare Development Office (MSWDO), intends to grant Social Pension to two hundred fifty (250) qualified Senior Citizens of this municipality;

WHEREAS, the said undertaking has been found to be compliant with the rules and regulations provided in the Memorandum Circular No. 04, Series of 2019 issued by the DSWD;


NOW THEREFORE, premises considered, and on motion by Coun. Alberto C. Marzan Jr., duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health and Social Services, hereby supports the implementation of the Social Pension for Indigent Senior Citizens (SPISC) Program of the Department of Social Welfare and Development in the Municipality of Moncada;
