RESOLUTION RECOMMENDING THE CREATION OF A TASK FORCE ADDRESSING THE SAFETY AND SANITATION PRACTICES ISSUES INVOLVING BUSINESS ESTABLISHMENTS

WHEREAS, cognizant of the adverse effects on the health and safety of the populace brought about by potential tragedies resulting from negligent acts of business owners, this August body deems it necessary to recommend the creation of a special task force that will address the root cause of these issues and concerns;

WHEREAS, to avert the occurrence of events inimical to the welfare of our people, urgent measures need to be employed to allay their fears and institute proactive approaches relative to disaster mitigation;

WHEREAS, any undertaking of this nature can be successful following a well-laid out plan of action by a special task force designated by authorities to perform monitoring and evaluation among business establishments;

NOW THEREFORE, on motion by Coun. Janius M. Yasay, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Rules and ordinances, hereby recommends the creation of a task force addressing the safety and sanitation practices issues involving business establishments;
