### RESOLUTION DENOUNCING THE ATROCITIES BEING PERPETRATED BY THE COMMUNIST TERRORIST GROUPS (CTGs) IN THE DIFFERENT AREAS OF THE COUNTRY, AND NOT TO ALLOW THEIR PRESENCE IN THE MUNICIPALITY OF MONCADA

WHEREAS, Moncada Municipal Police Station (MPS) endorsed to this Sanggunian a memorandum from the Provincial Director, Tarlac Police Provincial Office directing all Chief of Police of MPS to encourage the LGUs within their Area Of Responsibility (AOR) to craft resolutions denouncing the presence of Communist Terrorist Groups (CTGs) in their area and not to allow their presence in the Municipality;

WHEREAS, there was no report of CTG atrocity within the municipality of Moncada and the people of this town strongly desire that this situation be maintained;

NOW, THEREFORE, on motion by LNB PRES. GEORGE R. CUCHAPIN, duly seconded;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Peace and Order , Public Safety and Security, hereby denounces the atrocities being perpetrated by the Communist Terrorist Groups (CTGs) in the different areas of the country, and not allow their presence in the Municipality of Moncada;
