RESOLUTION ENDORSING THE CLOSURE OF SMART GIANT POULTRY FARM LOCATED AT BARANGAY CAPAOAYAN, THIS MUNICIPALITY FOR VIOLATING PERTINENT SANITATION AND ENVIRONMENTAL LAWS, RULES AND REGULATIONS

WHEREAS, endorsed to this August Body for investigation and in aid of legislation is the alleged violation committed by Smart Giant Corporation, a company that operates a poultry farm in Brgy. Capaoayan of this municipality;

WHEREAS, reports submitted by the Municipal Health Office reveal that the aforesaid facility is infested with swarms of flies and insects due to accumulation of animal manures, refuse and carcasses that are purportedly emitting foul odor that has caused discomfort and apprehension among the residents of Brgy. Capaoayan and other neighboring barangays;

WHEREAS, the Municipal Health Office thru its Sanitation Division has exhausted all legal means to compel the facility owners to comply with existing laws, rules and regulations governing the operation of such poultry farm, but despite all the warnings and notices served, the owner has remained non-compliant;

WHEREAS, Section 16 of Republic Act 7160 provides that the Local Government Unit shall exercise the powers which are essential to the promotion of the general welfare of its constituencies;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, Social Services and Environmental Protection hereby endorses the **CLOSURE** of Smart Giant Poultry Farm located at Barangay Capaoayan, this municipality for violating pertinent sanitation and environmental laws, rules and regulations;

RESOLVED FURTHER, that this August Body earnestly requests the intervention of the Honorable Mayor Estelita M. Aquino to immediately issue a **CEASE AND DESIST ORDER** to Smart Giant Corporation until such sanitation issues are resolved and complied with by the owner;
