WHEREAS, Republic Act 7160 otherwise known as the Local Government Code of 1991, specifically Article One, Section 444 (b) (1) (vi), provides that the Municipal Mayor, upon authorization by the Sangguniang Bayan, shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations and such other documents made pursuant to law or ordinance;

WHEREAS, Mrs. Cristina A. Gabriel, duly appointed Municipal Treasurer shall take charge of the disbursement of all local government funds and such other funds the custody of which may be entrusted to her by law or other competent authority pursuant to Section 470 (d) (2) of the Local Government Code;

RESOLVED, that the Sangguniang Bayan of Moncada hereby authorizes the Honorable Mayor Estelita M. Aquino and Municipal Treasurer Cristina A. Gabriel to sign checks and all warrants drawn for the expenditures of the Municipality of Moncada for Administrative Year 2019 – 2022;
