AUTHORIZING THE HONORABLE ESTELITA M. AQUINO, MUNICIPAL MAYOR, REPRESENTING THE MUNICIPAL GOVERNMENT OF MONCADA, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL FOOD AUTHORITY (NFA) TARLAC PROVINCIAL OFFICE, IN REGARD TO RICE LOAN PROGRAM

WHEREAS, under the Local Government Code, LGUs are authorized to set aside 5% of their regular income for Calamity Fund to ensure prompt and efficient delivery of basic social services in times of calamities;

WHEREAS, relative to this, the NFA is implementing a Rice Loan Program wherein the LGUs are allowed to purchase Rice on Credit from said national government agency;

WHEREAS, under the program, the Rice Loan is intended for relief operations wherever a state of calamity is declared in the locality and for stockpiling in preparation for eventualities/emergencies that may occur at any given time;

NOW, THEREFORE, on motion by COUN. RUBEN V. GAMBOA, JR. and unanimously seconded;

RESOLVED, that this Sanggunian hereby authorizes the Honorable Estelita M. Aquino, Municipal Mayor, representing the Municipal Government of Moncada, to enter into a Memorandum Of Agreement (MOA) with the National Food Authority (NFA) Tarlac Provincial Office, in regard to Rice Loan Program;
