**RECOMMENDING THE LIFTING OF THE CEASE AND DESIST ORDER ISSUED BY THE LOCAL GOVERNMENT UNIT OF MONCADA TO SMART GIANT CORPORATION AND AUTHORIZING THE RESUMPTION OF OPERATIONS THEREOF, SUBJECT TO THE SAME LAWS, RULES AND REGULATIONS GOVERNING SUCH ENTITIES**

WHEREAS, this August Body is in receipt of a Motion for Reconsideration from Smart Giant Corporation with a prayer for the lifting of Cease and Desist Order issued by the Office of the Mayor on June 11, 2019 to the owner, Dr. Artonie A. Ariado, for violation of sanitation laws, rules and regulations;

WHEREAS, the Office of the Mayor, Municipal Health Office and the SB Committee on Health, Sanitation and Environmental Protection conducted a dialogue and public hearing on July 8, 2019 along with the business owner and the affected parties to jointly discuss the issues and concerns and the proposed remedial measures to be undertaken that would resolve sanitation issues;

WHEREAS, the owner presented its proposed sanitation measures which include fly and pest control program and several preventive approaches to avert the proliferation of flies and control the stench of animal carcasses and manures;

WHEREAS, the affected parties were receptive to the proposed re-opening of the poultry farm on a precondition that the owner must employ and exhaust all necessary means to prevent the recurrence of similar incidents;

RESOLVED, that this Sanggunian, acting on the favorable recommendation of the Committee on Health, Sanitation, Social Welfare and Environmental Protection hereby recommends the lifting of the Cease and Desist Order issued by the Local Government Unit of Moncada to Smart Giant Corporation and authorizing the resumption of operations thereof, subject to the same laws, rules and regulations governing such entities;
